ISSUE AGREEMENT

THIS ISSUE AGREEMENT ("AGREEMENT") IS MADE AT MUMBAI, INDIA ON THIS DATE OF JULY 07, 2025, BY AND BETWEEN

1. **KANISHK ALUMINIUM INDIA LIMITED**, a company incorporated under the Companies Act, 2013 and having its registered office at Plot No. E-849 A, Fourth Phase RIICO, Boranada - 342001, Jodhpur, Rajasthan, India. (hereinafter referred to as "**Issuer**" or the "**Company**", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns);

AND


2. **Sun Capital Advisory Services Private Limited**, a company incorporated under the provisions of Companies Act, 1956, through its authorized signatory Ajesh Dalal (PAN No AHQPD6433R) and having its registered Office at 302, 3rd Floor, Kumar Plaza, Near Kalina Market, Kalina Kurla Road, Santacruz East, Mumbai - 400029, Maharashtra, India (hereinafter referred to as "**LM**" or "**Lead Manager**", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns);

In this Agreement, the Company and the LM are collectively referred to as the "**Parties**" and individually as a "**Party**".

WHEREAS:

- (A) The Issuer is proposing to undertake an SME - Initial Public Offering of up to 40,00,000 equity shares face value ₹ 10 each of the Issuer ("**Equity Shares**") and such proposed issue, ("**Issue**"), through the fixed price method ("**Fixed Price**"), as prescribed in the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended from time to time ("**SEBI ICDR Regulations**"), at a price as may be decided by the Issuer in consultation with the Lead Manager ("**Issue Price**"); in accordance with the Companies Act, 2013 ("**Act**") as defined herein, the SEBI ICDR Regulations and

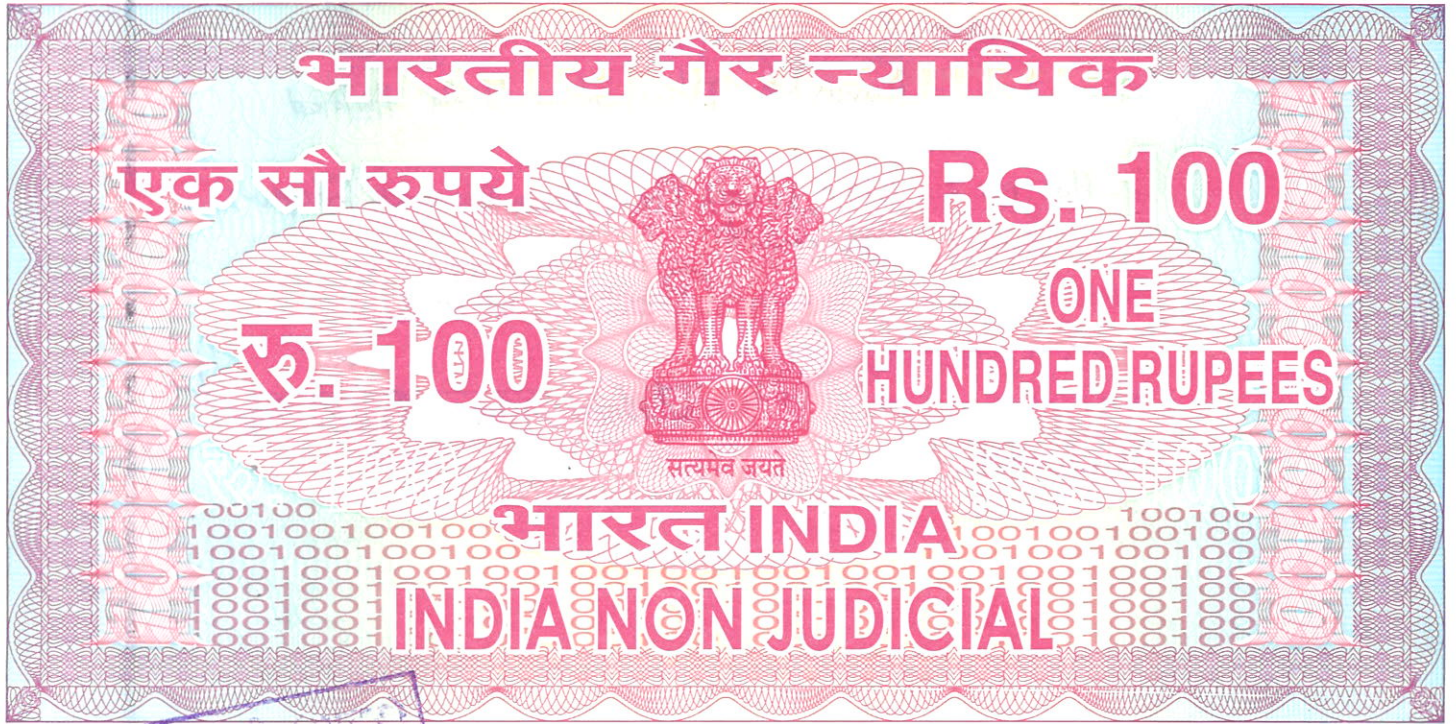

(C) The Company has approached and appointed the LM to manage the Issue as Lead Manager for the Issue. The LM has accepted the engagement in terms of engagement letter dated June 15, 2023 ("Engagement Letter") subject to the terms and conditions set forth therein;

(D) The agreed fees and expenses payable to the LM for managing the Issue is set forth in the Engagement Letter.


(E) The LM is entering into this Agreement with the Company, in compliance with the SEBI ICDR Regulations to record and set forth certain terms and conditions for and in connection with the Issue.

NOW, THEREFORE, the Parties do hereby agree as follows:

1. DEFINITIONS AND INTERPRETATION

1.1 All capitalized terms used in this Agreement, including the recitals, shall, unless specifically defined herein, have the meanings assigned to them in the Issue Documents (as defined herein), as the context requires. In the event of any inconsistencies or discrepancies, the definitions in the Issue Documents shall prevail. The following terms shall have the meanings ascribed to such terms below:

"Engagement Letter" shall have the meaning given to such term in Recital (C);

"ICAI" shall mean the Institute of Chartered Accountants of India;

"Issue" shall have the meaning given to such term in Recital (A);

"Issue Documents" shall mean the Draft Prospectus and the Prospectus, the Application Form including the abridged prospectus, the Confirmation of Allocation Notes, the Allotment Advice and any amendments, supplements, notices, corrections or corrigenda to such issue documents and the preliminary or final international supplement/wrap;

"Issue Price" shall have the meaning given to such term in Recital (A);


"Indian Counsel" shall mean the Indian Counsel appointed by the Company as Legal Counsel for the purpose of the IPO;

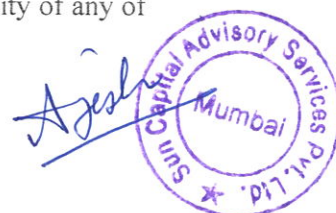

"Material Adverse Change" shall mean, individually or in the aggregate, a material adverse change, as determined by the LM in its sole discretion, probable or otherwise, (i) on the reputation, condition (financial, legal or otherwise), assets, liabilities, earnings, revenues, profits, cash flows, business, management, operations or prospects of any of the Company Entities, or their respective Affiliates, either individually or taken as a whole and whether or not arising from transactions in the ordinary course of business, (ii) on the ability of any of

the Company Entities, or their respective Affiliates, either individually or taken together as a whole, to conduct their businesses and to own or lease their respective assets or properties in substantially the same manner in which such businesses were previously conducted or such assets or properties were previously owned or leased as described in the Issue Documents (exclusive of all amendments, corrections, corrigenda, supplements or notices to investors), or (iii) on the ability of the Company to perform their respective obligations under, or to complete the transactions contemplated by, this Agreement, the Engagement Letter or the Underwriting Agreement, including the issuance, allotment, sale and transfer of the Equity Shares contemplated herein or therein;

"Market Maker" shall mean any person who is registered as a Market Maker with the SME platform of SME Platform of BSE.

"Market Maker Reservation Portion" shall mean the reserved portion for the Designated Market Maker of Equity Shares as described in the Prospectus of face value of ₹ 10 each at Issue Price as described in the Prospectus-

"Market Making Agreement" shall mean the Agreement entered between the Issuer Company, Lead Manager and Market Maker

"Issue Opening Date" shall have the same meaning ascribed to it in the Prospectus;

"Issue Closing Date" shall have the same meaning ascribed to it in the Prospectus;

"Person" shall mean and includes any individual, sole proprietorship, partnership, unincorporated association, unincorporated syndicate, unincorporated organization, trust, body corporate, and a natural person in his capacity as trustee, executor, administrator, or other legal representative;

"Public Issue Account" shall mean the Public Issue Account as and when opened by the Issuer Company with a designated Banker to the Issue in order to collect the subscription monies procured from this Issue of Shares

"Public Issue" or "Issue" shall mean fresh issue of upto **40,00,000** Equity Shares of face value of ₹ 10 each fully paid up at the Issue Price.

"RBI" shall mean the Reserve Bank of India;

"Registrar of Companies" shall mean the Registrar of Companies, situated at Ahmedabad, Gujarat with which the Prospectus shall be filed by the Company;

"SCRA" shall mean the Securities Contracts (Regulation) Act, 1956, as amended;


"SCRR" shall mean the Securities Contracts (Regulation) Rules, 1957, as amended;

"SEBI" shall mean the Securities and Exchange Board of India;

"SEBI Act" shall mean the Securities and Exchange Board of India Act, 1992, as amended;

"Transaction Documents" shall mean, collectively, this Agreement, the Banker to the Issue Agreement and the Underwriting Agreement;

"Underwriter" shall mean the underwriter to the Issue as per the Prospectus filed with Stock Exchange, SEBI and ROC.


"Underwriting Agreement" shall mean agreement entered between the Issuer, the Lead Manager and Underwriter(s);

"Working Days" shall mean all days, excluding Saturdays, Sundays and public holidays, on which commercial banks are open for business; and the time period between the Issue Closing Date and the listing of the Equity Shares on the SME Platform of BSE, shall mean all trading days SME Platform of BSE, excluding Sundays and bank holidays in a in accordance with Regulation 2(1)(mmm) of SEBI ICDR Regulations

- 1.1 In this Agreement, unless the context otherwise requires:
 - 1.1.1 words denoting the singular number shall include the plural and vice versa;
 - 1.1.2 heading and bold typeface are only for convenience and shall be ignored for the purposes of interpretation;
 - 1.1.3 references to the word "include" or "including" shall be construed without limitation;
 - 1.1.4 references to Agreement or to any other agreement, deed or other instrument shall be construed as a reference to such agreement, deed, or other instrument as the same may from time to time be amended, varied or supplemented or any replacement or novation thereof;
 - 1.1.5 a reference to a clause, section or paragraph is, unless indicated to the contrary, a reference to a clause, section or paragraph of this Agreement;
 - 1.1.6 unless otherwise defined the reference to the word "days" shall mean calendar days.
 - 1.1.7 references to a statute or statutory provision shall be construed as a reference to such provisions as from time to time amended, consolidated, modified, extended, re-enacted or replaced.
 - 1.1.8 On the basis of the representations and warranties contained in this Agreement and subject to its terms and conditions, the Lead Manager hereby agree to manage the offer solely and, on the terms, and conditions contained herein in this Agreement.

1. ISSUE TERMS

- 1.1 The Issue will be managed by the LM in accordance with the terms of this Agreement.
- 1.2 The Parties agree that entering into this Agreement or the Engagement Letter shall not create any obligation, or be deemed to impose, any obligation, agreement or commitment, whether express or implied, on the LM, or any of their Affiliates, to purchase, or place any Equity Shares, or enter into any underwriting agreement with or provide any financing or underwriting to the Company, its Affiliates in connection with the Issue. For the avoidance of doubt, this Agreement is not intended to constitute and should not be construed as an agreement or commitment directly or indirectly among the Parties with respect to the subscription, underwriting or purchasing of the Equity Shares or placing any securities or to provide any financing to the Company, its Affiliates and such commitment will be made only by the execution of the Underwriting Agreement and in the event the Company and the LM enter into an Underwriting Agreement, such agreement may, inter alia, include customary representations and warranties, conditions as to closing of the Issue (including the provision of comfort letters, arrangement letters and legal opinions), indemnity, contribution, termination and *force majeure* provisions, in form and substance satisfactory to the parties to the Underwriting Agreement.

- 1.3 The rights, obligations, representations, warranties, covenants, undertakings and indemnities (as applicable) of each of the Parties under this Agreement shall (unless expressly set out under this Agreement) be several, and not joint, and none of the Parties shall be responsible for the information, obligations, representations, warranties or for any acts or omissions of any other Party.
- 1.4 The Company shall not, without the prior approval of the LM, file the Draft Prospectus or the Prospectus with the SEBI, the SME Platform of BSE, the Registrar of Companies or any Governmental Authority whatsoever, as the case maybe.
- 1.5 The Company in consultation with the LM, shall decide the terms of the Issue, the Issue Price, Issue Opening Date and the Issue Closing Date, including for Qualified Institutional Buyers and Anchor Investors, including any revisions thereof;
- 1.6 The Company, in consultation with the LM, shall make applications to the Stock Exchange for listing of the Equity Shares and shall obtain in-principle approvals from the Stock Exchange. The Company further undertakes that it shall take all necessary steps for the completion of the necessary formalities for listing and commencement of trading of the Equity Shares on the Stock Exchange within such time period as may be prescribed under Applicable Law.
- 1.7 The Basis of Allotment and all allocations, and allotments made pursuant to the Issue shall be in accordance with Applicable Law and shall be undertaken by the Company in consultation with the LM and SME Platform of BSE.
- 1.8 The Company shall ensure that all fees and expenses relating to the Issue, including underwriting commissions, procurement commissions, if any, and brokerage due to the underwriters and sub-brokers or stock brokers, fees payable to the Self-Certified Syndicate Banks, legal advisor and any other agreed fees and commissions payable in relation to the Issue shall be paid within the time prescribed under the agreements to be entered into with such persons and as set forth in their respective engagement letter(s), in accordance with Applicable Law.
- 1.9 The Company undertakes and agrees that they shall not access the money raised in the Issue until receipt of the final listing and trading approvals from the SME Platform of BSE. until which time all monies received shall be kept in a separate bank account in a scheduled bank, within the meaning of Section 40(3) of the Companies Act, 2013. The Company shall refund the money raised in the Issue, together with any interest, to the Applicants if required to do so for any reason, including, without limitation, due to the failure to obtain listing or trading approval from the SME Platform of BSE or pursuant to any direction or order of SEBI or any other Governmental Authority. The Company shall pay interest on such money as required under the Applicable Law.
- 1.10 The Company shall take such steps as are necessary to ensure the completion of listing and commencement of trading of the Equity Shares on the SME Platform of BSE within 3 Working Days of the Issue Closing Date as per SEBI circular, or any other time period as may be prescribed under Applicable Law. The Company shall further take all necessary steps, in consultation with the LM, to ensure the dispatch of the Confirmation of Allocation Notes, completion of the allotment of the Equity Shares pursuant to the Issue, dispatch of the Allotment Advice promptly, and dispatch of the refund orders (if any) to the applicants, including the unblocking of ASBA Accounts in relation to ASBA Applicants and non-resident applicants in any case not later than the time limit prescribed under Applicable Law, and in the event of failure to do so, to pay interest to the applicants as required under Applicable Law.

- 1.11 The Company agrees and undertakes that: (i) refunds/unblocking of funds to the unsuccessful applicants or dispatch of Allotment Advice shall be made in accordance with the methods described in the Issue Documents; and (ii) funds required for making refunds to unsuccessful applicants, in accordance with the methods described in the Issue Documents, shall be made available.
- 1.12 The Company shall comply with the SEBI circular (CIR/OIAE/1/2013) dated April 17, 2013 in relation to redressal of investor grievances through the SEBI Complaints Redress System (SCORES) and shall set up an investor grievance redressal system to redress all Issue-related grievances to the satisfaction of the LM and in compliance with Applicable Law.
- 1.13 The LM shall have the right to withhold submission of any of the Issue Documents to the SEBI, the Registrar of Companies or the BSE SME in the event that any of the information requested by the LM is not made available by the Company, or any of their respective Affiliates or any other Company Entity immediately on request by the LM.
- 1.14 The Company acknowledges and agrees that the Equity Shares have not been and will not be registered under the US Securities Act and may not be offered or sold within the United States, except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the US Securities Act and outside the United States in offshore transactions, in reliance on Regulation S under the US Securities Act.

2. COVENANTS BY ISSUER, REPRESENTATIONS, WARRANTIES AND UNDERTAKINGS BY THE COMPANY; SUPPLY OF INFORMATION AND DOCUMENTS

The Company represents, warrants and undertakes to the LM the following:

- 2.1 Each of the Company Entities has been duly incorporated, registered and is validly existing and is in good standing as a company under Applicable Law, has the corporate power and authority to own or lease its movable and immovable properties and to conduct its business (including as described in the Issue Documents) and no steps have been taken for its winding up, liquidation or receivership under any Applicable Law; and except as disclosed in the Issue Documents, the Company has no other subsidiaries, joint ventures and associate companies.
- 2.2 The Issuer hereby declares that they have complied with or agree to comply with all the statutory formalities under the Companies Act, SEBI ICDR Regulations and other conditions, instructions and advice issued by SEBI and other relevant statutes to enable them to make the Issue.
- 2.3 The Issuer hereby declares that the Company, its Promoters and its Directors are not declared as willful defaulters or fraudulent borrowers as defined under regulation 2(1)(III) or a fugitive economic offender as defined under regulation 2(1)(p) of the SEBI ICDR Regulations.
- 2.4 The Issuer and the Promoter undertake and declare that any information made available to the LM or any statement made in Draft Prospectus/Prospectus shall be complete in all respects and shall be true and correct and that under no circumstances they shall give or withhold any information or statement which is likely to mislead the investors.
- 2.5 The Issuer undertakes to furnish complete audited annual reports, other relevant documents, papers, information relating to pending litigations, etc. to enable the LM to corroborate the information and statements given in the Issue Documents.

- 2.6 The Issuer shall, if required, extend such facilities as may be called for by the LM to enable them to visit the business site, office of the issuer or such other places to ascertain for themselves the state of affairs of the issuer including the progress made in respect of the project implementation, status and other facts relevant to the Issue.
- 2.7 The Issuer shall extend all necessary facilities to the LM to interact on any matter relevant to the Issue with the Legal Advisors, Auditors, Consultants, Advisors to the Issue, Financial Institutions, Banks or any other organization and any other intermediary associated with the Issue in any capacity whatsoever.
- 2.8 The Issuer shall not, without the prior consent of the LM, appoint other intermediaries (except Self Certified Syndicate Banks) or other persons associated with the Issue such as advertising agencies, printers, etc. for printing the application forms, allotment advice, allotment letters, share certificates, refund orders or any other instruments, circulars, or advices. The Issuer shall, whenever required and wherever applicable, in consultation with the LM, enter into an agreement or understanding with the intermediaries associated with the Issue, clearly setting forth their mutual rights, responsibilities and obligations. A certified true copy of such agreement(s) or understanding(s) shall be given to the LM. The Issuer shall take all such necessary steps to ensure completion of allotment and dispatch of allotment/refund orders and credit of shares to demat accounts and unblocking of funds to the applicants within the prescribed time. Further, The Issuer shall take necessary steps to pay fees, underwriting commission, brokerage to the underwriters, stockbrokers, SCSBs, registered intermediaries, LM etc., as applicable, within the time specified as per the terms agreed with such intermediaries or within a reasonable time.
- 2.9 The Issuer shall ensure that all advertisements prepared and released by the advertising agency or otherwise in connection with the Issue conform to the SEBI ICDR Regulations and the instructions given by the LM from time to time. The Issuer and the Promoter shall not make any misleading or incorrect statement in any public communication or publicity material including corporate, product and Issue advertisements of the issuer, interviews by its promoters, directors, duly authorized employees or representatives of the Issuer, documentaries about the Issuer or its promoters, periodical reports and press releases issued by the Issuer or research report made by the Issuer, any intermediary concerned with the Issue or their associates or at any press, brokers' or investors' conferences.
- 2.10 The Issuer, the Promoter shall, whenever required and wherever applicable, in consultation with the LM, enter into an agreement with the intermediaries associated with the Issue, clearly setting forth their mutual rights, responsibilities and obligations. A certified true copy of such agreements shall be furnished to the LM.
- 2.11 The Issuer and the Promoter undertake to furnish such information and particulars regarding the Issue as may be required by the LM to enable them to file a report with the SEBI in respect of the Issue.
- 2.12 The Issuer and the Promoter shall keep the LM informed if they encounter any problems due to dislocation of communication system or any other adverse material circumstance which is likely to prevent or which has prevented the Issuer and the Promoter from complying with their obligations, whether statutory or contractual, in respect of the matters pertaining to allotment, dispatch of refund orders, share certificates, demat credit, etc.

Further, any information made available, or to be made available, to the LM or its legal counsel and any statement made, or to be made, in the Issue Documents, or otherwise in connection with the Issue, shall be true, fair, correct, accurate, not misleading and without omission of any matter that is likely to mislead, and adequate to enable prospective investors to make a well informed decision and shall be immediately updated until the commencement of trading of the Equity Shares on the SME Platform of BSE, and the Company agrees and undertakes to ensure that under no



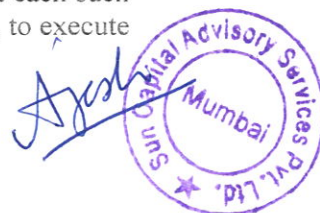

 - (ii) each of the Issue Documents, as of the date on which it has been filed, does not contain any untrue statement of a material fact or omit to state a material fact necessary in order to make the statements therein, in the light of the circumstances under which they are made, not misleading;
 - (iii) the LM shall be entitled to assume without independent verification that each such signatory has been duly authorized by the Company, as the case may be, to execute



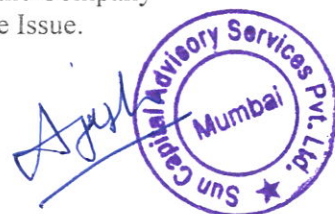
- 2.91 Neither the Company nor any of its Affiliates, nor any director, officer, or employee, nor, any agent or representative of the Company or its Affiliates, has taken or will take any action (i) in furtherance of an offer, payment, promise to pay, or authorization or approval of the payment or giving of money, property, gifts or anything else of value, directly or indirectly, to any "government official" (including any officer or employee of a government or government-owned or controlled entity or of a public international organization, or any person acting in an official capacity for or on behalf of any of the foregoing, or any political party or party official or candidate for political office) to influence official action or secure an improper advantage; or (ii) that has resulted or will result in a violation by the Company or the Company's Affiliates of the Prevention of Corruption Act, 1988, U.S. Foreign Corrupt Practices Act of 1977, as amended, and the rules and regulations thereunder (the "FCPA"), or the U.K. Bribery Act, 2010 or any similar statutes in any of the jurisdictions in which they have operations; and the Company and its Affiliates have conducted their businesses in compliance with (i) applicable anti-corruption laws, and (ii) the FCPA, and have instituted and maintain and will continue to maintain policies and procedures designed to promote and achieve compliance with such laws and with the representation and warranty contained herein.

- 3.2 The Company shall, to the extent permissible under the terms of the respective agreements with such intermediary, instruct all intermediaries, including the Registrar to the Issue, the Bankers to the Issue/ the Escrow Collection Banks, Refund Banks, advertising agencies printers, and brokers to follow the instructions of the LM and shall make best efforts to include a provision to that effect in the respective agreements with such intermediaries.

- 3.4 If in the sole opinion of the LM, due diligence of the Company's, its Affiliates' or any other entity's records, documents or other information in connection with the Issue requires hiring of services of technical, legal or other experts or persons, the Company shall promptly hire and provide such persons with access to all relevant records, documents and other information of the Company and their respective Affiliates and any other relevant entities. The Company shall instruct all such persons to cooperate and comply with the instructions of the LM and shall include a provision to that effect in the respective agreements with such persons. The expenses of such persons shall be paid directly by the Company; *provided that* if it is necessary that the LM pay such persons, then the Company shall reimburse in full the LM for payment of any fees and expenses to such persons.

4. APPOINTMENT OF INTERMEDIARIES

- 4.1 The Company shall, in consultation with the LM, appoint intermediaries (other than the Self Certified Syndicate Banks) and other entities as are mutually acceptable to the Parties, including the Registrar to the Issue, monitoring agency, the Bankers to the Issue / the Escrow Collection Banks, Refund Banks, advertising agencies, printers and brokers.
- 4.2 The Parties agree that any intermediary that is appointed shall, if required, be registered with the SEBI under the applicable SEBI rules, regulations and guidelines. Whenever required, the Company shall, in consultation with the LM, enter into a memorandum of understanding, engagement letter or agreement with the concerned intermediary associated with the Issue, clearly setting forth their mutual rights, responsibilities and obligations. All costs, charges, fees and expenses relating to the Issue, including road show, accommodation and travel expenses and fees and expenses paid by the Company to any of the intermediaries shall be paid as per the agreed terms with such intermediaries. A certified true copy of such executed memorandum of understanding, engagement letter or agreement shall promptly be furnished to the LM.
- 4.3 The LM and its Affiliates shall not, directly or indirectly, be held responsible for any action or omission of any intermediary appointed in respect of the Issue. However, the LM shall co-ordinate, to the extent required by Applicable Law or under any agreements to which they are parties, the activities of all the intermediaries in order to facilitate the performance of their respective functions in accordance with their respective terms of engagement. The Company acknowledges and agrees that any such intermediary, being an independent entity and not the LM or its Affiliates, shall be fully and solely responsible for the performance of its duties and obligations.
- 4.4 The Parties agree and acknowledge that the terms of appointment of any of the intermediaries including syndicate member or other advisor in relation to the Issue shall be negotiated separately with such entities and shall not affect or have any bearing on fees payable to the LM.
- 4.5 The Company acknowledges and takes cognizance of the deemed agreement of the Company with the Self Certified Syndicate Banks for purposes of any ASBA process (as set out under the SEBI ICDR Regulations), as well as with the Designated Intermediaries for the purposes of collection of Application Forms in the Issue, as set out in the Issue Documents.

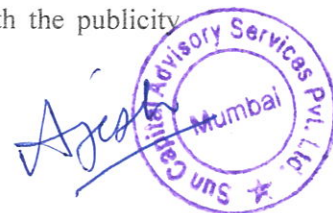
5. PUBLICITY FOR THE ISSUE

The Company also agrees that it will not, and its respective Affiliates will not engage in publicity activities in any other jurisdiction in which the Equity Shares under the Issue are being offered, during the period in which it is prohibited under the laws of each jurisdiction.

5.2 The Company and their respective Affiliates shall, during the restricted period under Section 6.1 above, obtain the prior written consent of the LM and the Indian Legal Counsel in respect of all advertisements, press releases, publicity material or any other media communications in connection with the Issue. The Company shall maintain a record of all such Issue related material and shall make available to the LM copies of all such Issue related material.

5.3 The Company and their respective Affiliates shall comply with, and shall also ensure that any advertisements, press releases, publicity material or other communications comply with, all Applicable Law, including the SEBI ICDR Regulations. The Company and any of their respective Affiliates shall not make any statement or release any material or other information in any advertisements or any other form of publicity relating to the Issue, including:

- (i) at any corporate, press, brokers' or investors' conferences in respect of the Issue;
- (ii) in any interviews by the directors, key managerial personnel or employees or representatives of the Company or any of their respective Affiliates;
- (iii) in any documentaries about the Company Entities, the Promoters;
- (iv) any periodical reports or press releases issued by the Company or any of their respective Affiliates; and
- (v) to any person, including any research analyst in any manner whatsoever, including at road shows, presentations and in research or sales reports or at Application centers,

which is misleading or incorrect or which is not disclosed in the Issue Documents, or that does not conform to Applicable Law, including the SEBI ICDR Regulations and the instructions given by the LM or the Indian Legal Counsel appointed in relation to the Issue, from time to time.

5.4 Subject to Applicable Law, including publicity restrictions issued by the SEBI, the Company agrees that the LM may, at its own expense, place advertisements in newspapers and other external publications describing its involvement in the Issue and the services rendered by it, and may use the Company's name and logo(s) in this regard. The LM undertakes and agrees that such advertisements shall be issued only after the date on which the Equity Shares under the Issue are approved for trading on the SME Platform of BSE and in the event that approval for trading on each of the SME Platform of BSE occurs on different dates, the later date shall be the relevant date for the purpose of this section.

5.5 The Company undertakes that it shall enter into an agreement with a press/advertising agency to monitor the news reports, for the period between the date of filing of the Draft Prospectus and the date of closure of the Issue, appearing in any of the following media:

- (i) newspapers where the statutory advertisements are published;
- (ii) major business magazines; and
- (iii) print and electronic media controlled by a media group where the media group has a private treaty/shareholders' agreement with the Company or Promoters of the Company.

5.6 The Company hereby confirms that it shall procure and provide all information and certifications (including from any publicity/press/advertising agency) to enable the LM to furnish the certificate to the SEBI as required under Regulation 264 read with Schedule IX of the SEBI ICDR Regulations.

- 5.7 In the event that any advertisement, publicity material or any other media communication in connection with the Issue is made in breach of the restrictions set out in this Section 6, the LM shall have the right to request the immediate withdrawal, cancellation, denial or clarification of such advertisement, publicity material or any other media communications.

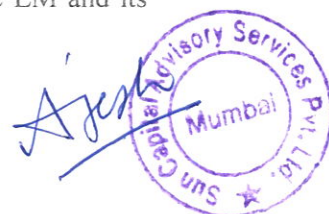
6. DUTIES OF THE LM AND CERTAIN ACKNOWLEDGEMENTS

6.1 The Company agrees and acknowledges that:

- (i) The LM shall have no liability to the Company or its respective Affiliates for any actions or omissions of, or the performance by the underwriters or any other intermediary appointed in connection with the Issue;
- (ii) the LM owes to the Company only those duties and obligations expressly set forth in this Agreement;
- (iii) the duties and responsibilities of the LM under this Agreement shall not include general financial or strategic advice, and in particular shall not include providing services as receiving bankers or registrars. No tax, legal, regulatory, accounting, technical or specialist advice is being given by the LM;
- (iv) any purchase and sale of Equity Shares pursuant to an underwriting agreement, including the determination of the Issue Price, shall be an arm's length commercial transaction between the Company and the LM, subject to the execution of the Underwriting Agreement. The LM is acting as a principal and not as an agent or fiduciary or advisor of the Company or its stockholders, creditors, employees or any other party;
- (v) The LM may have interests that differ from those of the Company. Neither this Agreement nor the LM's performance hereunder nor any previous or existing relationship between the Company and the LM or its Affiliates shall be deemed to create any fiduciary relationship in connection with the Issue. The Company waives to the fullest extent permitted by Applicable Law any claims it may have against the LM arising from any alleged breach of fiduciary duties in connection with the Issue or otherwise;
- (vi) the Company is solely responsible for making their own judgments in connection with the Issue, irrespective of whether the LM has advised or is currently advising the Company on related or other matters;
- (vii) the LM shall not be held responsible for any acts of commission or omission of the Company or their respective Affiliates, any intermediaries or their respective directors, officers, agents, employees, consultants, representatives, advisors or other authorized persons;
- (viii) the LM may provide the services hereunder through one or more of its Affiliates, as LM deems advisable or appropriate. The LM shall be responsible for the activities carried out by its Affiliates in relation to this Issue and for its obligations hereunder;
- (ix) the provision of services by the LM under this Agreement is subject to the requirements of any Applicable Law in respect of the LM and its Affiliates. The LM and its Affiliates are authorized by the Company to take any action which they consider is appropriate, necessary or desirable to carry out the services under this Agreement or under the Engagement Letter or to comply with any Applicable Laws, including any codes of conduct, authorizations, consents or practice and the Company hereby agrees to ratify and confirm all such actions lawfully taken;
- (x) The LM and its Affiliates are engaged in a wide range of financial services and businesses (including asset management, financing, securities or derivatives trading and brokerage, insurance, corporate and investment banking and research). In the ordinary course of its activities, the LM and its Affiliates may at any time hold "long" or "short" positions and may trade in or otherwise effect transactions for their own account or accounts of customers in debt or equity securities of any company that may be involved in the Issue. There may be situations where the LM and its


Affiliates and/or their clients either now have or may in the future have interests, or take actions that may conflict with the Company's interests. For example, the LM or its Affiliates may, in the ordinary course of business, engage in trading in financial products or undertake other investment businesses for their own account or on behalf of other clients, including, but not limited to, trading in or holding long, short or derivative positions in securities, loans or other financial products of the Company, their respective Affiliates or other entities connected with the Issue. The LM and its Affiliates shall not restrict their activities as a result of this engagement, and the LM and its respective Affiliates may undertake any business activity without further consultation with, or notification to, the Company. Neither this Agreement nor the receipt by the LM or its Affiliates of confidential information or any other matter shall give rise to any fiduciary, equitable or contractual duties (including any duty of trust or confidence) that would prevent or restrict such LM or its Affiliates from acting on behalf of other customers or for their own accounts or in any other capacity;

- (xi) The LM and its Affiliates, its directors, officers and employees may also at any time invest on a principal basis or manage funds that invest on a principal basis, in debt or equity securities of any company that may be involved in the Issue, or in any currency or commodity that may be involved in the Issue, or in any related derivative instrument. Further, the LM may, at any time, engage, in ordinary course, broking activities for any company that may be involved in the Issue; and
- (xii) the LM and/or its Affiliates may be representing and/or may have provided financial advisory and financing services for and received compensation from any one or more of the parties which are or may hereafter become involved in this transaction. The LM and/or its Affiliates may, in the future, seek to provide financial services to and receive compensation from such parties. None of the relationships described in this Agreement or the services provided by the LM to the Company or any other matter shall give rise to any fiduciary, equitable or contractual duties (including any duty of confidence) which would preclude or limit in any way the ability of the LM and/or its Affiliates from providing similar services to other customers, or otherwise acting on behalf of other customers or for their own respective accounts. The Company acknowledges and agrees that, by reason of law or duties of confidentiality owed to other persons, or the rules of any regulatory authority, the LM may be prohibited from disclosing information to the Company (or such disclosure may be inappropriate), including information as to Affiliates' possible interests as described in this paragraph and information received pursuant to client relationships.

6.2 The obligations of the LM in relation to the Issue shall be conditional, *inter alia*, upon the following:

- (iv) due diligence having been completed to the sole satisfaction of the LM, including enabling the LM to file any due diligence certificate with SEBI (or any other

Governmental Authority) and any other certificates as are customary in offerings of the kind contemplated herein;

- (v) terms and conditions of the Issue having been finalized in consultation with and to the satisfaction of the LM, including the Issue Price, the Anchor Investor Issue Price and the size of the Issue;
- (vi) completion of all regulatory requirements (including receipt of all necessary approvals and authorizations, and compliance with the conditions, if any, specified therein, in a timely manner) and receipt of and compliance with all consents, approvals and authorizations under applicable contracts required in relation to the Issue, compliance with all Applicable Law governing the Issue and disclosures in the Issue Documents, all to the sole satisfaction of the LM;
- (vii) completion of all documentation for the Issue, including the Issue Documents and the execution of certifications (including certifications and comfort letters from the statutory auditors of the Company, in form and substance satisfactory to the LM, within the rules of the code of professional ethics of the ICAI containing statements and information of the type ordinarily included in accountants' "comfort letters" to the LM with respect to the financial statements and certain financial information contained in or incorporated by reference into the Issue Documents, each dated as of the date of (i) the Draft Prospectus, (ii) the Prospectus, and (iii) the allotment of the Equity Shares pursuant to the Issue; provided that each such letter delivered shall use a "cut-off date" not earlier than a date three days prior to the date of such letter), undertakings, consents, legal opinions (including the opinion of Indian Legal Counsel on each of the date of the Prospectus, the signing of the Underwriting Agreement and the allotment of the Equity Shares in the Issue) and the Other Agreements, and where necessary, such agreements shall include provisions such as representations and warranties, conditions as to closing of the Issue, force majeure, indemnity and contribution, in form and substance satisfactory to the LM;
- (viii) the benefit of a clear market to the LM prior to the Issue, and in connection therewith, the absence of any debt or equity offering of any type or any offering of hybrid securities, other than the Issue, undertaken, or being undertaken subsequent to the filing of the Draft Prospectus, by the Company or any of their respective Affiliates, without the prior written consent of the LM;
- (ix) the receipt of approval from the respective internal committees of the LM whose approval may be given in the sole determination of each such committee;
- (x) the Company having not breached any term of this Agreement or the Engagement Letter; and
- (xi) the absence of any of the events referred to in Section 18.3(v).


7. EXCLUSIVITY

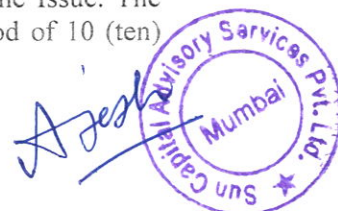
The LM shall be the exclusive lead LM to the Company in respect of the Issue. The Company shall not, during the term of this Agreement, appoint any other lead manager, co-manager, syndicate member or other advisor in relation to the Issue without the prior written consent of the LM. Nothing contained herein shall be interpreted to prevent the Company from retaining legal counsel or such other advisors as may be required for taxation, accounts, legal matters, employee matters, due diligence and related matters in connection with the Issue. However, the LM and their respective Affiliates shall not be liable in any manner whatsoever for any acts or omissions of any other advisor appointed by the Company.

8. CONSEQUENCES OF BREACH

- 8.1 In the event of a breach of any of the terms of this Agreement, the non-defaulting Party shall, without prejudice to the compensation payable to it under this Agreement, have the absolute right to take such action as it may deem fit, including withdrawing from the Issue. The defaulting Party shall have the right to cure any such breach within a period of 10 (ten)

calendar days of the earlier of:

- i. becoming aware of the breach; and
- ii. being notified of the breach by the non-defaulting Party.

In the event that the breach is not cured within the aforesaid period, the defaulting Party shall be liable for the consequences, if any, resulting from such termination and withdrawal.

- 8.2 Notwithstanding Section 9.1 above, in the event that the Company or any of their Affiliates fail to comply with any of the provisions of this Agreement, the LM has the right to immediately withdraw from the Issue either temporarily or permanently, or to suspend or terminate their engagement without prejudice to the compensation or expenses payable to it under this Agreement or the Engagement Letter.
- 8.3 The LM shall not be liable to refund the monies paid to them, including fees, commissions and reimbursement of out-of-pocket expenses specified under this Agreement or the Engagement Letter unless the breach is caused solely due to the gross negligence or willful default on the part of the LM as may be finally determined by the court of competent jurisdiction.

9. GOVERNING LAW

This Agreement, the rights and obligations of the Parties hereto, and any claims or disputes relating thereto, shall be governed by and construed in accordance with the laws of India and subject to Section 11 below, the courts of Mumbai, India, shall have exclusive jurisdiction in all matters arising out of this Agreement.

10. ARBITRATION

- 10.1 In the event a dispute arises out of or in relation to or in connection with the existence, validity, interpretation, implementation, termination, alleged breach or breach of this Agreement or the Engagement Letter or the legal relationships established by this Agreement or the Engagement Letter (the "**Dispute**"), the Parties to such Dispute shall attempt, in the first instance, to resolve such Dispute through amicable discussions among such disputing parties. In the event that such Dispute cannot be resolved through amicable discussions within a period of seven (7) days after the first occurrence of the Dispute, the Parties (the "**Disputing Parties**") shall, by notice in writing to each other, refer the Dispute to binding arbitration to be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 (the "**Arbitration Act**").
- 10.2 Any reference of the Dispute to arbitration under this Agreement shall not affect the performance of terms, other than the terms related to the matter under arbitration, by the Parties under this Agreement and the Engagement Letter.
- 10.3 The arbitration shall be conducted as follows.
- (i) all proceedings in any such arbitration shall be conducted, and the arbitral award shall be rendered, in the English language;
 - (ii) all Disputes between the Parties arising out of or in connection with this Agreement shall be referred to or submitted to arbitration in Mumbai;
 - (iii) the Company shall appoint one arbitrator and the LM shall appoint one arbitrator and the two arbitrators shall appoint the third or the presiding arbitrator. In the event that the LM or the Company fail to appoint an arbitrator or the arbitrators fail to appoint the third arbitrator as provided herein within 30 days from the date of receipt of the notice required under Section 11.1 above, such arbitrator(s) shall be appointed in accordance with the Arbitration Act; and each of the arbitrators so appointed shall have at least five years of relevant experience in the area of securities and/or commercial laws;

- (iv) the arbitrators shall have the power to award interest on any sums awarded;
- (v) the arbitration award shall state the reasons on which it was based;
- (vi) the arbitration award shall be final, conclusive and binding on the Parties and shall be subject to enforcement in any court of competent jurisdiction;
- (vii) the Disputing Parties shall share the costs of such arbitration proceedings equally unless otherwise awarded or fixed by the arbitrators;
- (viii) the arbitrators may award to a Disputing Party its costs and actual expenses (including actual fees and expenses of its counsel);
- (ix) the Disputing Parties shall co-operate in good faith to expedite the conduct of any arbitral proceedings commenced pursuant to this Agreement; and
- (x) subject to the foregoing provisions, the courts in Mumbai, Maharashtra, India shall have jurisdiction in relation to proceedings, including with respect to grant of interim relief, brought under the Arbitration Act.

11. SEVERABILITY

If any provision or any portion of a provision of this Agreement or the Engagement Letter is or becomes invalid or unenforceable, such invalidity or unenforceability shall not invalidate or render unenforceable this Agreement or the Engagement Letter, but rather shall be construed as if not containing the particular invalid or unenforceable provision or portion thereof, and the rights and obligations of the Parties shall be construed and enforced accordingly. The Parties shall use their best reasonable efforts to negotiate and implement a substitute provision which is valid and enforceable and which as nearly as possible provides the Parties with the benefits of the invalid or unenforceable provision.

12. BINDING EFFECT, ENTIRE UNDERSTANDING


12.1 The terms and conditions of this Agreement shall be binding on and inure to the benefit of the Parties hereto. Except in relation to the fees and expenses contained in the Engagement Letter, these terms and conditions supersede and replace any and all prior contracts, understandings or arrangements, whether oral or written, heretofore made between any of the Parties hereto and relating to the subject matter hereof, and as of the date hereof constitute the entire understanding of the Parties with respect to the Issue, unless expressly stated otherwise in this Agreement. In the event of any inconsistency or dispute between the terms of this Agreement and the Engagement Letter, the terms of this Agreement shall prevail, provided that the Engagement Letter shall prevail over this Agreement solely where such inconsistency or dispute relates to the fees or expenses payable to the LM for the Issue or any Taxes payable with respect thereto.

12.2 From the date of this Agreement up to the commencement of trading in the Equity Shares, the Company shall not enter into any initiatives, agreements, commitments or understandings (whether legally binding or not) with any person which may directly or indirectly affect or be relevant in connection with the Issue or this Agreement without the prior consent of the LM. The Company further confirms that as on the date of signing of this Agreement and until the listing and the trading of the Equity Shares, none of the Company, any of their respective Affiliates or Directors have entered or will enter into any contractual arrangement, commitment or understanding relating to the offer, sale, distribution or delivery of Equity Shares without prior consultation with, and the prior written consent of the LM.

13. INDEMNITY

13.1 The Company shall indemnify and hold harmless the LM, its respective Affiliates, and their respective directors, officers, employees, agents and Controlling persons and each person, if any, who controls, is under common control with or is controlled by, any manager (the LM and each such person, an "Indemnified Party") at all times, from and against any and all

claims, actions, losses, damages, penalties, liabilities, costs, charges, expenses, suits, or proceedings of whatever nature (including reputational) made, suffered or incurred, including any legal or other fees and expenses actually incurred in connection with investigating, disputing, preparing or defending any actions claims, suits or proceedings (individually, a "Loss" and collectively, "Losses"), to which such Indemnified Party may become subject under any Applicable Law consequent upon or arising, directly or indirectly, out of or in connection with or in relation to (i) the Issue, this Agreement or the Engagement Letter or the activities contemplated thereby, or (ii) any breach or alleged breach of any representation, warranty, declaration, confirmation, covenant or undertaking by the Company, its Affiliates, directors, officials, employees, representatives, agents, consultants and advisors in this Agreement, the Other Agreements, the Issue Documents, or any undertakings, certifications, consents, information or documents furnished or made available to the Indemnified Party, and any amendment or supplement thereto, or in any marketing materials, presentations or written road show materials prepared by or on behalf of the Company in relation to the Issue, or (iii) any untrue statement or alleged untrue statement of a material fact contained in the Issue Documents, or in any other information or documents, prepared by or on behalf of the Company or any amendment or supplement to the foregoing, or the omission or the alleged omission to state therein a material fact required to be stated or necessary in order to make the statements therein in light of the circumstances under which they were made not misleading, or (iv) the transfer or transmission of any information to any Indemnified Party by the Company or its Affiliates in violation or alleged violation of any Applicable Law in relation to confidentiality or insider trading (including in relation to furnishing information to analysts), and/or in relation to any breach or alleged breach by the Indemnified Parties in relation to the issuance of research reports in reliance upon and/or consequent to information furnished by the Company or its Affiliates and/or their advisors, agents, representatives, consultants, directors, employees and officials, or (v) any correspondence (written or otherwise) with the SEBI, the RBI, the Registrar of Companies, the SME Platform of BSE or any other Governmental Authority in connection with the Issue or any information provided by the Company or its Affiliates, directors, officials, employees, representatives, agents, consultants and advisors to an Indemnified Party to enable such Indemnified party to correspond, on behalf of the Company with any Governmental Authority in connection with the Issue. The Company shall pay for all such expenses (including, without limitation, any legal or other expenses and disbursements) on behalf of the Indemnified Party as they are incurred by such Indemnified Party(s) in connection with investigating, disputing, preparing or defending any such action or claim, whether or not in connection with pending or threatened litigation to which the Indemnified Party may become subject, in each case, directly to the concerned entity/ person, as and when it becomes due.

- 13.2 In case any proceeding (including any investigation by any Governmental Authority) is instituted involving any person in respect of which indemnity may be sought pursuant to Section 14.1, the Indemnified Party shall promptly notify the person against whom such indemnity may be sought (the "Indemnifying Party") in writing *provided that* the failure to notify the Indemnifying Party shall not relieve such Indemnifying Party from any liability that it may have under this Section 14. The Indemnifying Party, at the option of and upon request of the Indemnified Party, shall retain counsel reasonably satisfactory to the Indemnified Party to represent the Indemnified Party and any other persons that the Indemnifying Party may designate in such proceeding and shall pay the fees and disbursements of such counsel related to such proceeding. In any such proceeding, any Indemnified Party shall have the right to retain its own counsel, but the fees and expenses of such counsel shall be at the expense of the Indemnified Party unless: (i) the Indemnifying Party and the Indemnified Party have mutually agreed to the retention of such counsel, (ii) the Indemnifying Party has failed within a reasonable time to retain counsel reasonably satisfactory to the Indemnified Party, (iii) the Indemnified Party has reasonably concluded that there may be legal defenses available to it that are different from or in addition to those available to the Indemnifying Party, or (iv) the named parties to any such proceedings



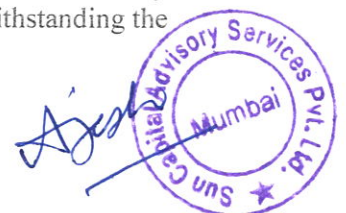


(including any impleaded parties) include both the Indemnifying Party and the Indemnified Party and representation of both parties by the same counsel would be inappropriate due to actual or potential differing interests between them. The Parties acknowledge and agree that the Indemnifying Party shall not, in respect of the legal expenses of any Indemnified Party in connection with any proceeding or related proceedings in the same jurisdiction, be liable for the fees and expenses of more than one separate firm (in addition to any local counsel) for all such Indemnified Parties and that all such fees and expenses shall be reimbursed as they are incurred. In the case of any such separate firm, such firm shall be designated in writing by the LM. The Indemnifying Party shall not be liable for any settlement of any proceeding effected without its written consent, but if settled with such consent or if there exists a final judgment for the plaintiff, the Indemnifying Party shall indemnify the Indemnified Party from and against any loss or liability by reason of such settlement or judgment. Notwithstanding the foregoing, if at any time an Indemnified Party shall have requested an Indemnifying Party to reimburse the Indemnified Party for fees and expenses of counsel as contemplated earlier in this Section 14, the Indemnifying Party shall be liable for any settlement of any proceeding effected without its written consent if (i) such settlement is entered into more than 30 (thirty) days after receipt by such Indemnifying Party of the aforesaid request and (ii) such Indemnifying Party shall not have reimbursed the Indemnified Party in accordance with such request prior to the date of such settlement. No Indemnifying Party shall, without the prior written consent of the Indemnified Party, affect any settlement of any pending or threatened proceeding in respect of which any Indemnified Party is or could have been a party and indemnity could have been sought hereunder by such Indemnified Party, unless such settlement includes an unconditional release of such Indemnified Party from all liability or claims that are the subject matter of such proceeding and does not include a statement as to an admission of fault, culpability or failure to act, by or on behalf of the Indemnified Party.

- 13.3 To the extent the indemnification provided for in this Section 14 is unavailable to an Indemnified Party, or is held unenforceable by any court of law, arbitrator, arbitral tribunal or any other Governmental Authority, or is insufficient in respect of any Losses referred to therein, then each Indemnifying Party under this Section 14, in lieu of indemnifying such Indemnified Party, shall contribute to the amount paid or payable by such Indemnified Party as a result of such Losses (i) in such proportion as is appropriate to reflect the relative benefits received by the Company on the one hand and the LM on the other hand from the Issue or (ii) if the allocation provided by Section 14.3(i) above is not permitted by Applicable Law, in such proportion as is appropriate to reflect not only the relative benefits referred to in Section 14.3(i) above but also the relative fault of the Company on the one hand and of the LM on the other hand in connection with the statements or omissions that resulted in such losses, claims, damages or liabilities, as well as any other relevant equitable considerations. The relative benefits received by the Company on the one hand and the LM on the other hand in connection with the Issue shall be deemed to be in the same respective proportions as the net proceeds from the Issue (before deducting expenses) received by the Company and the total fees (excluding expenses) received by the LM, bear to the aggregate proceeds of the Issue. The relative fault of the Company on the one hand and of the LM on the other hand shall be determined by reference to, among other things, whether the untrue or alleged untrue statement of a material fact or disclosure or the omission or alleged omission to state a material fact or disclosure relates to information supplied by the Company or their respective Affiliates, or their respective directors, officials, employees, representatives, advisors, consultants or agents, or by the LM, and the Parties' relative intent, knowledge, access to information and opportunity to correct or prevent such statement or omission.
- 13.4 The Parties acknowledge and agree that the amount paid or payable by an Indemnified Party as a result of the losses, claims, damages and liabilities referred to in Section 14 shall be deemed to include any legal or other expenses reasonably incurred by such Indemnified Party in connection with investigating or defending any such action or claim. Notwithstanding the

provisions of this Section 14, the LM shall not be required to contribute any amount in excess of the fees received by the LM pursuant to this Agreement and/or the Engagement Letter. No person guilty of fraudulent misrepresentation shall be entitled to contribution from any person who was not guilty of such fraudulent misrepresentation. Notwithstanding anything contained in this Agreement, in no event shall the LM be liable for any special, incidental or consequential damages, including lost profits or lost goodwill.

- 13.5 The remedies provided for in this Section 14 are not exclusive and shall not limit any rights or remedies that may otherwise be available to any Indemnified Party at law or in equity.
- 13.6 The indemnity and contribution provisions contained in this Section 14 and the representations, warranties, covenants and other statements of the Company contained in this Agreement shall remain operative and in full force and effect regardless of any (i) termination of this Agreement or the Engagement Letter, (ii) investigation made by or on behalf of any Indemnified Party or by or on behalf of the Company or its officers or Directors or any person Controlling the Company, or (iii) acceptance of and payment for any Equity Shares.
- 13.7 Notwithstanding anything stated in this Agreement, the maximum aggregate liability of the LM under this Agreement shall not exceed the lead manager fees actually received by the LM from the Company for its portion of the services rendered under this Agreement.

14. FEES AND EXPENSES

- 14.1 The Company shall pay the fees and expenses of the LM as specified in the Engagement Letter.


15. TAXES

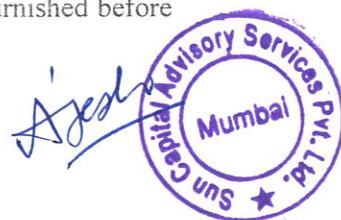
- 15.1 All payments due under this Agreement and the Engagement Letter are to be made in Indian Rupees. The Company shall promptly pay (or in compliance with all applicable laws, procure payment of), any fees, stamp, registration or other taxes and duties, including interest and penalties, payable on, or in connection with, the Issue. The Company shall also pay any GST, sales, service or similar taxes, cess, duties or charges payable in connection with the payment of commission and fees payable to the LM in accordance with the terms of their respective Engagement Letter and the Underwriting Agreement.

16. CONFIDENTIALITY

- 16.1 The LM agrees that all confidential information relating to the Issue and disclosed to the LM by the Company or their respective Affiliates or by the Directors, whether furnished before



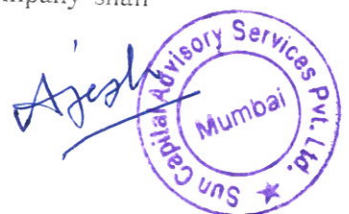

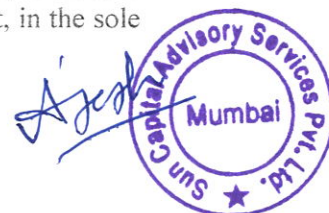

- 16.6 Subject to Section 17.1 above, the LM shall be entitled to retain all information furnished by the Company and their respective Affiliates, directors, employees, agents, representatives or legal or other advisors, any intermediary appointed by the Company and the notes, workings, analyses, studies, compilations and interpretations thereof, in connection with the Issue, and to rely upon such information in connection with any defenses available to the LM or its respective Affiliates under Applicable Law, including any due diligence defense. The LM shall be entitled to retain copies of any computer records and files containing any information which have been created pursuant to its automatic electronic archiving and back-up procedures. 17. TERM AND TERMINATION

- 17.1 This Agreement shall be subject to termination by notice in writing given by either party. The Lead Manager to the Issuer, if subsequent to the execution and delivery of this Agreement; and prior to the Issue Opening Date:
- (a) of its obligations under this Agreement or otherwise or in the assets, liabilities, earnings, business, prospects, management or operations of the Issuer that, in the sole judgment of the Lead Manager, is material and adverse and that makes it, in the sole

- (c) the Lead Manager has not been able to complete its due diligence to its satisfaction or has found a materially adverse finding in its due diligence;
- (d) there shall have occurred a Material Adverse Change in the financial markets in India, which makes it, in the reasonable judgment of the Lead Manager impracticable to proceed with the Issue, such as any outbreak of hostilities or terrorism or escalation thereof or any calamity or crisis affecting the international financial markets, and in each case the effect of which event, may be taken into account by the Lead Manager singularly or together with any other such event. Further, a general banking moratorium shall not have been declared by India, the European Union, the United Kingdom and the United States of America; or
- (e) there shall have occurred a regulatory change, (including, but not limited to, a change in the regulatory environment in which the Company operates or a change in the regulations and guidelines governing the terms of this Issue) or an order or directive from SEBI, ROC, stock exchange or any other governmental, regulatory or judicial authority pertaining to the securities market(s) that, makes it, in the reasonable judgment of the Lead Manager, impossible or renders the Company ineligible to proceed with the Issue.

17.2 The LM's engagement shall commence with effect from the date of the Engagement Letter, and shall, unless terminated earlier pursuant to the terms of the Engagement Letter or this Agreement, continue until the earlier of: (i) the commencement of trading of the Equity Shares on the SME Platform of BSE; or (ii) withdrawal of the Issue, whichever is earlier, or such other date that may be agreed among the Parties. The Parties agree that the Issue Documents will be withdrawn from SEBI as soon as practicable after the termination of this Agreement pursuant to (ii) above.

17.3 Notwithstanding Section 18.2 above, LM may, at its sole discretion, unilaterally terminate this Agreement in respect of itself immediately by a notice in writing:

- (i) if any of the representations, warranties, undertakings, declarations or statements made by the Company and/or its Directors in the Issue Documents, advertisements, publicity materials or any other media communication, in each case in relation to the Issue, or in this Agreement or the Engagement Letter, or otherwise in relation to the Issue are determined by the LM to be incorrect, untrue or misleading either affirmatively or by omission;
- (ii) if the Engagement Letter or the Underwriting Agreement in connection with the Issue are terminated pursuant to their respective terms;
- (iii) if there is any non-compliance or breach by the Company Entities of Applicable Law in connection with the Issue or its obligations, representations, warranties or undertakings under this Agreement or the Engagement Letter;
- (iv) if the Issue is postponed beyond the term as provided in Section 18.2 or withdrawn or abandoned for any reason prior to 12 (twelve) months from the date of the Engagement Letter; or
- (v) in the event that:
 - (a) trading generally on the National Stock Exchange of India Limited, the London Stock Exchange, the New York Stock Exchange or the NASDAQ Global Market, Tokyo Stock Exchange has been suspended or materially limited or minimum or maximum prices for trading have been fixed, or maximum ranges have been required, by any of these exchanges or by the U.S. Securities and Exchange Commission, the Financial Industry Regulatory Authority or any other applicable Governmental Authority or a material



- (b) a general banking moratorium shall have been declared by India, United Kingdom, United States Federal or New York State authorities;
- (c) there shall have occurred any material adverse change in the financial markets in India, the United States, United Kingdom or the international financial markets, any outbreak of hostilities or terrorism or escalation thereof or any calamity or crisis or any other change or development involving a prospective change in Indian, the United States, United Kingdom or other international political, financial or economic conditions (including the imposition of or a change in currency exchange controls or a change in currency exchange rates) in each case the effect of which event, singularly or together with any other such event, is such as to make it, in the sole judgment of the LM impracticable or inadvisable to proceed with the Issue, allotment, listing of the Equity Shares on the terms and in the manner contemplated in the Issue Documents;
- (d) there shall have occurred any change, or any development involving a prospective change, in the condition, financial or otherwise, or in the earnings, assets, liabilities, business, management, properties, results of operations or prospects of any of the Company Entities whether or not arising in the ordinary course of business that, in the sole judgment of the LM, is a Material Adverse Change and that makes it, in the sole judgment of the LM, impracticable or inadvisable to proceed with the Issue, allotment, listing of the Equity Shares on the terms and in the manner contemplated in the Issue Documents; or

- 17.7 The termination of this Agreement shall not affect the LM's right to receive any fees which may have accrued to it prior to the date of termination and reimbursement for out-of-pocket and other Issue related expenses incurred prior to such termination as set out in the Engagement Letter. The LM shall not be liable to refund any amounts paid as fees, commissions, reimbursements, out-of-pocket expenses or expenses specified under the Engagement Letter if the termination of this Agreement occurs as a result of any act or omission of the Company or their respective Affiliates.

- 18.5 All notices issued under this Agreement shall be in writing (which shall include e-mail, telex or facsimile messages) and shall be deemed validly delivered if sent by registered post or recorded delivery to or left at the addresses as specified below or sent to the e-mail address
