Brief Note Explaining the Process of Due Diligence Carried out in the proposed SME IPO of Kanishk Aluminium India Limited (“Company”)

I. Process followed for preliminary check before accepting our engagement as the Lead Manager:

- A. We had asked for and studied the following information of the Issuer:
 1. Brief Profile or Presentation about the Issuer covering its Management, Promoter(s), Business and Corporate Structure;
 2. Annual Reports of the Company for latest three Financial Years
 3. Checked information available on the website of the Issuer;
 4. Other available information of the Issuer in public domain
- B. Post completing the preliminary due diligence and analysis of the basic information about the Issuer, we had checked the eligibility of the proposal.
- C. We had a concall with the Top Management of the Issuer to discuss about their background, business in detail and asked queries based on our observation and understanding of studied information.
- D. Post finding that the proposal was worthy enough to take it forward, we invited the Top Management of the Issuer in our office for meeting and discussions on SME IPO listing and further detail discussions on business and their future plan and funds requirements.
- E. Then, we visited the registered office of the Issuer and their office infrastructure and met the Promoter and other management team. The Company specializes in manufacturing a wide range of aluminum extrusion products, including solid & hollow section profiles, solar profiles, railings, windows and doors. The Company's products serve a diverse array of industries, such as electronics, automotive, mechanical, solar, furniture, electrical, and architecture. The Company has also last year launched the brand, 'Baari by Kanishk', for premium aluminium system doors and windows. Its manufacturing unit is located in Jodhpur, Rajasthan, spanning about 40,000 sq. ft., and is dedicated to the production of aluminum extrusions products. The Company's primary raw material is aluminium-based metal scrap, which they source from both domestic and international markets.

I Preliminary Process:

A. We had asked for and reviewed the following information of the Issuer before planning for their Plant and Registered Office Visit:

1. Annual Reports of the Company for latest three Financial Years
2. Checked information available on the website of the Issuer
3. Checked information available under Assets Schedule under Annual Reports
4. Business related information received as per our Initial Checklist
5. Group and Organization related information received as per our Initial Checklist
6. Other available information of the Issuer in public domain

B. Post completing the preliminary due diligence and analysis of the basic information about the Issuer, we decided to visit their factory unit, Registered Office and other properties.

C. Then, we visited the registered office and met Managing Directors, CFO, KMPs and other employees of the Company.

D. We also called and met their existing Statutory Auditor.

E. We explained Top Management team of the Issuer about the process of SME IPO, various key activities needed to be taken in future, key role of CFO, CS & Promoter required during the process of proposed IPO, regulatory requirements of Companies Act and SEBI Acts and specially, the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulation 2018, as amended etc.

F. Then, we visited the factory unit of the Issuer and reviewed infrastructure and met their factory in-charge and other employees and workers.

G. We requested plant in-charge and Managing Director to follow sequence of our movement during the visit in the manner in which manufacturing process moves i.e. to start the visit from raw material entry, its storing, checking, processing, then manufacturing to finished products, their storage and dispatch.

II Observations of Plant and Registered Office Visit

- A. The Company is engaged in the business of manufacturing of aluminium extrusion products including solid & hollow section profiles, solar profiles, railings, heatsinks and sliding / fixed windows and doors profiles. The products of the Company serve a diverse array of industries, such as electronics, automotive, mechanical, solar, furniture, transport, electrical, and architecture.
- B. The Company has manufacturing unit located in Jodhpur, Rajasthan, spans approximately 4,000 square meters. This facility is dedicated to producing precision aluminum extrusions according to the industry standards. The various variety of dies used in manufacturing are custom-made and owned by our Company. The main raw material is aluminium-based metal scrap, which we source from domestic markets. Additionally, for the new range of products under brand “Baari by Kanishk”, the Company has established a display cum show centre in Jodhpur, for providing customers with direct access to explore the premium products offerings as well as branding and promotion.
- C. We have also visited the utility available such as Electricity load, Water, factory office, Security staff, and entry and exit system etc.
- D. We had various discussions during our visit and tried to understand system and processes in place. We also reviewed various documents / information on Registered Office and factor sites, including –
 - i. Various business-related documents, the processes they follow, their market and products, their various bills & other documents.

III. Facts about the manufacturing facilities and Registered Office Visit

- A. We refer to visit of manufacturing facilities of the Issuer’s from May 27, 2025 to May 29, 2025 in relation to the proposed SME IPO of the Company.

- C. The site visit may be summarized as follows:
 - i. At the outset, a kick-off discussion was held to understand the aforesaid aspects at the aforesaid manufacturing facilities. The discussion was attended by Mr. Parmanand Agrawal, Promoter, Mr. Ashish Agrawal, Promoter, Mr. Nitin Pandey, CFO and other senior personnel of the Company, representatives of the Lead Manager to the Issue.

- ii. A broad overview of the industry in which the Company operates and the regulatory framework which was followed by detailed discussions with Mr. Ashish Agrawal, in relation to the system involved for process, storage and dispatch of finished goods, amongst other matters.
- iii. A detailed description of each product along with the raw material used, time taken in manufacturing each product, etc. was provided by the Company for the manufacturing facilities.
- iv. A live demonstration of manufacturing of different type of aluminium products, furnace, dies, how dies designing is done, including visit of R&D lab, Registered and factory office including the broad description of the manufacturing processes.
- v. Quality check process for raw materials followed at the manufacturing facilities whereby the sample quality checks are performed. The test samples are collected from batch of finished products to ensure the maintenance of quality standards and R&D purpose
